# 1. Controlled Operations

Controlled operations are undercover law enforcement operations where the participants have prior authority to technically break the law in order to investigate and deter crime and corrupt conduct.

The sophistication of many criminal and corrupt enterprises, or the consensual and private nature of more simple forms of criminal and corrupt conduct mean that they cannot or are unlikely to be penetrated by the normal array of law enforcement investigation measures. Only by infiltrating these criminal or corrupt conduct enterprises is it possible to gather the necessary evidence to arrest and prosecute offenders. However, such infiltration invariably requires the law enforcement participants to also commit offences. Infiltrating a drug trafficking enterprise, for example, will usually involve a law enforcement officer negotiating for the supply of drugs or actually buying and taking possession of drugs. Unless they were protected for these acts, the law enforcement participants would themselves be open to prosecution for the illegal acts. Unless the operations are authorised, the evidence they gather may also be open to challenge during any subsequent prosecutions on the basis that it was gathered illegally.

In recognition that an advanced investigatory tool was needed to effectively investigate certain types of crime and corrupt conduct, a number of jurisdictions have enacted legislation to authorise such controlled operations and provide immunities to their participants. In New South Wales, the *Law Enforcement (Controlled Operations) Act 1997* ('the Act') regulates these types of operations.

The central features of the regulatory framework for controlled operations include:

- The prescription of authorisation criteria and authorisation procedures.
- The imposition of binding conditions on those participating in controlled operations (including both law enforcement and non-law enforcement personnel).
- The imposition of a system of accountability incorporating controls and safeguards to ensure that powers under the Act and authorised activities are exercised in a responsible and appropriate manner and in accordance with the regime established by the Act.
- The provision of criminal immunities and civil indemnities to participating law enforcement officers and other authorised persons.
- Provisions ensuring that activities engaged in by a participant for the purposes of a controlled operation are not unlawful, despite any other Act or law.

## Key provisions of the legislation

The Act enables the chief executive officer or delegate of a prescribed law enforcement agency to authorise the conduct of a 'controlled operation' for a number of purposes. They are defined as:

- · obtaining evidence of criminal activity or corrupt conduct; or
- · arresting any person involved in criminal activity or corrupt conduct; or
- · frustrating criminal activity or corrupt conduct; or
- carrying out an activity that is reasonably necessary to facilitate the achievement of any of the above purposes.

An authority to conduct a controlled operation must identify each participant in the operation and the proposed unlawful conduct (ie. 'controlled activities') in which they may engage during the operation. It is not sufficient for the chief executive officer simply to approve an operation without also specifying the nature of the conduct or probable offences likely to be committed during its execution. Activities which but for the Act would be unlawful continue to be unlawful unless they are approved in advance. Authorities cannot be retrospective except in limited circumstances.

The Act prohibits the authorisation of operations that involve any participant engaging in conduct that is likely to seriously endanger the health or safety of a participant or any other person, or to result in serious loss or damage to property.

The Act also deals with the issue of entrapment. A key legal principal is that the culpability of an offender may be diminished if the actions of the law enforcement officers or authorities operate to induce the offender to commit an offence which otherwise might not have been committed (although it remains the fundamental task of the court to evaluate the criminality involved). It may be accepted that a mitigating factor might be that the offender was led by a participant in the operation into committing a more serious offence than otherwise might have been committed.

The provisions of sections 6 and 7 of the Act address the factors discussed in the case law that differentiate legitimate covert investigations from entrapment.<sup>1</sup> Section 7 of the Act specifically provides that an authority to conduct a controlled operation cannot be granted where the proposed operation involves inducing or encouraging any other person to engage in criminal activity or corrupt conduct of a kind that the other person could not reasonably be expected to engage in unless so induced or encouraged.

# Types of applications

The Act provides for two types of application 'Formal' and 'Urgent'. Formal Applications are made in writing, or by means of a facsimile transmission. Urgent applications are made by such other means as are available, including orally, by telephone or by two way radio.

Whether formal or urgent the application must provide the following particulars:

- a plan of the proposed operation;
- the nature of the criminal activity or corrupt conduct in respect of which the proposed operation is to be conducted;
- the nature of the controlled activity in respect of which the authority is sought; and
- a statement as to whether or not the proposed operation or any other controlled operation with respect to the same criminal activity or corrupt conduct, has been the subject of an earlier application for an authority or variation of an authority, and if so, whether or not the authority was given or the variation granted.

The Law Enforcement (Controlled Operations) Regulation 1998 provides that an urgent application to conduct or vary the authority for a controlled operation may be made if the urgency of the circumstances renders it impractical to make a formal application. In such circumstances, the applicant must ensure written notes are kept of:

- a) the date and time when the application is made
- b) the identity of the applicant
- c) the information given to the chief executive officer or delegate in support of the application.

Currently, the regulations have also made provision for the form in which formal authority is granted and the form in which a formal variation is granted.

After considering an application and any other additional information the chief executive officer or delegate may require, they may authorise the operation either unconditionally or subject to conditions, or refuse it.

## Mandatory considerations

An authority to conduct a controlled operation may not be granted unless the chief executive officer or delegate is satisfied as to the following matters:

- that there are reasonable grounds to suspect that criminal activity or corrupt conduct has been, is being or is about to be conducted in relation to matters within the administrative responsibility of the agency;
- that the nature and extent of the suspected criminal activity or corrupt conduct are such as to justify the conduct of a controlled operation;
- that the nature and extent of the proposed controlled activities are appropriate to the suspected criminal activity or corrupt conduct; and
- that the proposed controlled activities will be capable of being accounted for in sufficient detail to enable the reporting requirements of the Act to be fully complied with.

In George v Rocket (1990) 170 CLR 104, at 112, it was stated:

When a statute prescribes that there must be 'reasonable grounds' for a state of mind – including suspicion and belief – it requires the existence of facts which are sufficient to induce the state of mind in a reasonable person... That requirement opens many administrative decisions to judicial review and precludes the arbitrary exercise of many statutory powers...<sup>2</sup>

To be consistent with this approach the chief executive officer or delegate must be satisfied that there are sufficient grounds to induce the state of mind specified. Therefore, the material considered by the chief executive officer or delegate in the application and operational plan should in fact contain sufficient facts to found the reasonable suspicion.

When considering an application the chief executive officer or delegate must have regard to the following matters:

- the reliability of any information as to the nature and extent of the suspected criminal activity or corrupt conduct;
- the likelihood of success of the proposed controlled operation; and
- the duration of the proposed controlled operation.

### Variations

The Act allows for the varying of certain details of a controlled operation including its duration. Each variation can extend an operation for no more than six months.

## **Code of Conduct**

All law enforcement participants in a controlled operation are bound to adhere to a comprehensive Code of Conduct that forms part of the Law Enforcement (Controlled Operations) Regulation 1998. The Code among other things provides that applicants and law enforcement participants must at all times act in good faith. Applicants must disclose all relevant information that might affect the way an application is determined, at the time of application and as soon as practical if they subsequently become aware of such information. In addition, the code requires that applications and reports on operations not contain anything that is incorrect or misleading in a material particular. All law enforcement and civilian participants must be properly briefed and the law enforcement participants must comply with lawful directions of the principal law enforcement officer and report any breaches of the Code.

# 2. Accountability under the Act

In recognition of the fact that the Act revokes some fundamental principles of criminal and civil liability, the Act incorporates a three-tier regime of accountability on agencies that carry out controlled operations.

### Internal accountability

The first level of accountability is internal to the agency. Apart from the rigour required of applications and the decision making process of the chief executive officer, the Act requires that within two months after completing an authorised operation, the principal law enforcement officer for the operation must cause a report to be given to the chief executive officer. Currently the Law Enforcement (Controlled Operations) Regulation 1998 specifies that these reports must include such matters relevant to the operation as each individual chief executive officer requires.

The Code of Conduct requires that, in preparing a report on the conduct of an authorised operation, the reporting officer must at all times act in good faith (sub-clause 6(1)). In particular, the reporting officer must ensure that the report:

- discloses all information of which the officer is aware as to matters required to be included in the report; and
- does not contain anything that is incorrect or misleading in a material particular.

If, after submitting a report on a controlled operation, the reporting officer becomes aware of:

- information that, had it been known to the officer when the report was prepared, should have been included in the report; or
- information that indicates that anything contained in the report is incorrect or misleading in a material particular.

The officer must ensure that the information is given to the chief executive officer as soon as practicable.

### External accountability provided by the Ombudsman

The second level of accountability is external to the agency and involves the Ombudsman as an independent monitoring and inspection agency.

#### Notifications

The Act requires that the Ombudsman be notified of all grants of an authority, and variations to an authority. The Ombudsman must also be notified of all occasions on which the chief executive officer receives a report on a controlled operation. Notices must be provided to the Ombudsman within 21 days of the event to which the notice relates.

The Regulation sets out what must be included in each notice. In relation to notices that an authority has been granted, the notice must include the following information:

- the date on which the authority was granted;
- the serial number or other identifying code for the authority;
- the nature of the suspected criminal activity or corrupt conduct in respect of which the authority was granted;
- the period for which the authority is to remain in force;
- the nature of the controlled activities authorised by the authority;
- the number of participants in the operation together with an indication of:
  - how many of them are law enforcement participants; and
  - how many of them are civilian participants (clause 8).

A notice of variation of an authority must include the following information:

- the date on which the variation of authority was granted;
- the serial number or other identifying code of the authority to which the variation relates;
- if the variation extends the period for which the authority has effect, the period for which the authority is extended;
- if the variation authorises an alternative principal law enforcement officer for the operation, the fact that it does so;
- if the variation authorises additional or alternative persons to engage in controlled activities for the purposes of the operation, the number of persons so authorised together with an indication of:
  - how many of them are law enforcement participants; and
  - how many of them are civilian participants;
- if the variation authorises participants in the operation to engage in additional or alternative controlled activities, the nature of the controlled activities so authorised (clause 9).

A notice of receipt of a report on a controlled operation must include the following information:

- the date on which the report was received from the principal law enforcement officer for the operation;
- the serial number or other identifying code of the authority for the operation and any variations that have been granted;
- the serial number or other identifying codes of any authorities, and any variations of authority, that have been granted for previous controlled operations with respect to the same criminal activity or corrupt conduct;
- the nature of the controlled activities engaged in for the purposes of the operation;
- the number of participants in the operation together with an indication of:
  - how many of them were law enforcement participants; and
  - how many of them were civilian participants;
- a statement as to whether the operation was conducted in accordance with the authority for the operation and, in particular, as to:
  - whether any unlawful conduct was engaged in by any participant in the operation; and
  - if so, whether that unlawful conduct was the subject of an application for retrospective authority under s.14 of the Act [life threatening situations]; and
  - if so, whether retrospective authority was granted;
- the date on which the operation was completed.

In addition, s.21(2) of the Act provides that the Ombudsman may require the chief executive officer to furnish such other information concerning the authorities, variations, and reports as he considers necessary for the proper consideration of them.

#### Inspections

The second important role of the Ombudsman is to conduct inspections of the internal records of the agencies to assess compliance with the requirements of the Act. The Act requires that the Ombudsman inspect the records of each law enforcement agency at least once every twelve months although the Ombudsman may inspect the records of each agency at any time.

For the purposes of these inspections the Ombudsman has the same powers as under the *Telecommunications* (*Interception and Access*) (*New South Wales*) Act 1987. Under these provisions the Ombudsman:

- may enter at any reasonable time premises occupied by the authority after notifying the chief executive officer;
- is entitled to full and free access at all reasonable times to all records of the agency;
- is entitled to make copies of, and to take extracts from, records of the authority;
- may require an officer of the agency to provide such information as is in their possession or to which they have access that the Ombudsman considers relevant and necessary to the inspection;
- may summon an officer (including the chief executive officer) to attend before an inspecting officer to answer questions relevant to the inspection.

Officers of the agencies may not refuse to give information, refuse access to information nor refuse to answer questions on the basis that to do so would contravene a law, would be contrary to the public interest or might tend to incriminate the person. Information provided under compulsion may not be admissible in evidence against an officer, except in a proceeding for an offence under s.22 of the *Telecommunications (Interception and Access) (New South Wales) Act 1987.* Those proceedings relate to refusing or failing to comply with the Ombudsman's directions, hindering or resisting an inspection or providing false or misleading information.

Ombudsman officers inspect all authorities and variations to authorities granted during the reporting period. All documentation supporting the granting of authorities and variations to authorities is also inspected.

In addition, our inspection officers examine a sample of records held by the Principal Law Enforcement Officers responsible for the conduct of the operations in order to ascertain how those officers have accounted for the controlled activities carried out under the authorities.

# 3. Report to Parliament

The third tier of accountability is through the requirement on the Ombudsman to present an annual report to Parliament on the Ombudsman's work and activities under the Act for the preceding 12 months. This report is submitted in compliance with this obligation.

The Act sets out a range of particulars about the authorities granted by the law enforcement agencies that must be included in the report. In particular, s.23(2) requires details of the authorities that were granted or varied, the nature of the criminal or corrupt activities against which they were directed and the number of persons – both law enforcement officers and civilians – who were authorised to engage in controlled activities in respect of each authority. It also requires information about the activities that are actually engaged in and the number of persons involved.

It should be noted that s.24(1) of the Act imposes certain restrictions upon the information that may be included in this report. Specifically, the report must not include any information that, if made public, could reasonably be expected:

- (a) to endanger the health or safety of any person, or
- (b) to disclose the methodology used in any investigation (whether or not an authorised operation) that is being, has been or is proposed to be conducted by any law enforcement agency, or
- (c) to prejudice any investigation (whether or not an authorised operation) that is being or is proposed to be conducted by a law enforcement agency, or
- (d) to prejudice any legal proceedings arising from any such investigation.

Some of the details contained in this report have been curtailed by these restrictions.

# 4. Changes to Legislation

## **Surveillance Devices Act 2007**

The *Surveillance Devices Act 2007* commenced on 1 August 2008. The Act now authorises certain activities ancillary to the installation of surveillance devices including but not limited to entry onto premises, use of an assumed identity, the disconnection of security systems and connection to the electricity supply. A surveillance device warrant may also authorise the doing of anything reasonably necessary to conceal the fact that anything has been done in relation to the installation, use, maintenance or retrieval of a surveillance device.

As a result of these provisions it is generally no longer necessary to apply for a controlled operation in order to assist with the installation of a surveillance device as happened under the previous legislation. This accounts for the reduced number of such controlled operations, down from 45 in the last reporting period to 19 in this reporting period. Many of these operations were conducted to retrieve devices authorised under the *Listening Devices Act 1984*. It may still be necessary in some circumstances to use a controlled operation for the installation, maintenance or retrieval of a device where the particular facts of an operation are not covered by the provisions of the *Surveillance Devices Act 2007*. However, it is expected that this will occur in only a limited number of cases.

# 5. Inspection Overview

During the 2008–2009 financial year, 334 controlled operations were authorised and 328 operations completed. These numbers are similar to the number of operations conducted in the previous year.




## **NSW Police Force**

Section 23(2) of the Act requires that this report include certain particulars in relation to each law enforcement agency. Specific data relating to the operations conducted by NSW Police Force is included in tables annexed to this report. The records maintained by NSW Police Force and inspected by us (apart from those of the Professional Standards Command which are reported separately) disclose the following information<sup>6</sup>:

- There were 308 authorities granted by the Commissioner's delegates during the 2008–2009 reporting period. Of these 103 were varied. Two applications were refused. Nine urgent applications were made during the reporting period. Several applications were given identifying numbers but for one reason or another were not proceeded with prior to being formally considered for authorisation under the Act. As a result the numbers of operations listed in the appendix to this report may not be consecutive.
- There is some overlap in relation to the types of criminal activities targeted during controlled operations. In many instances an operation will target a range of criminal activities including prohibited drugs, firearm offences and armed robbery; as such the following figures represent a guide. The majority of the operations involved investigating criminal activities associated with the supply possession cultivation or manufacture of prohibited drugs. 235 controlled operations were connected in some way to prohibited drugs. Among the other operations, 38 targeted firearms, ammunition and explosives and other prohibited weapons offences, 20 involved the investigation of murder, conspiracy to murder, solicit to murder or attempted murder, 19 targeted robbery and armed robbery offences and break, enter and steal offences, seven operations targeted fraud, theft or stolen property offences and receiving, and another two operations targeted prostitution. Two operations targeted damage property by fire or explosion and four targeted stolen motor vehicles and vehicle re-birthing. One targeted fraud related offences and three involved pervert the course of justice. There were 16 'geographical' operations carried out. These operations involve the authorisation of controlled activities within a defined geographical boundary, often a particular Police Local Area Command and generally target drug and/or prostitution offences. There were 19 operations which involved engaging in controlled activities in order to facilitate the installation of electronic surveillance equipment. As mentioned previously, the passing of the Surveillance Devices Act 2007 has resulted in reduced numbers of these operations. By their nature these 'geographical' and 'installation' operations require the authorisation of a large number of participants due to the fact that it is not possible to foresee which of the law enforcement participants will actually be required to conduct controlled activities, and as such the total number of law enforcement participants noted below is high.
- The operations in total authorised 11,513 law enforcement participants and 213 civilian participants. The number of law enforcement participants authorised to be involved in individual operations ranged from zero to 240, while the number of civilian participants authorised for individual operations ranged from zero to three.
- In relation to the 298 operations which were completed by 30 June 2009 and reported to the chief executive officer, there were 531 law enforcement participants, and 161 civilian participants, who actually engaged in controlled activities.
- Since the majority of controlled operations involved investigations relating to the supply of prohibited drugs, the controlled activities engaged in for the purpose of the controlled operations, generally involved conversations and negotiations involving the supply of prohibited drugs, and the purchase and possession of prohibited drugs. Some operations also included entering enclosed lands, conversations and negotiations concerning prostitution, accessing restricted data, examination of property, make false statements, conversations concerning armed robbery, purchase and possession of prohibited firearms, discussions in relation to conspiracy to murder and conversations concerning stolen property.

#### **Outcome of inspections**

In past years the major issue of non-compliance with the requirements of the Act, has been the failure of Principal Law Enforcement officers to provide a report on the results of the operation to the chief executive officer within the two month statutory time frame, despite the failure to do so being a breach of the Code of Conduct. The provision of information relating to the briefing of civilian participants has also been a problem. The situation has improved greatly during 2008–2009. The number of delayed reports has been reduced markedly and the provision of records of civilian undertakings has increased. This has largely been achieved by NSW Police Force providing an officer permanently tasked with ensuring compliance with these requirements within the Special Application Section of the NSW Police Force Prosecutions Section. As a result the total number of delayed reports dropped this year from 160 to 50.

The records are generally retained at NSW Police Force, Court and Legal Services Special Application Section. The records were generally in order and in compliance with the requirements of the Act, with the following exceptions:

#### 2008/208

Section 12(2) of the Act states:

(2) Cancellation of an authority for a controlled operation takes effect at the time the order is made or at such later time as may be specified in the order.

Operation 2008/208 was cancelled but it was not clear from the file at what time the cancellation of the operation was to take effect.

This error has been noted by staff at the Special Applications Section (SAS), and an undertaking given that future documentation relating to cancellations will contain the time the cancellation takes effect.

#### 2009/028

Controlled activities were conducted after the expiry date of this operation. This was due to an error on the part of the PLEO who was mistaken in relation to the expiry date. The controlled activities concerned the registered source contacting the target of the operation by telephone to ascertain the availability of prohibited drugs and did not involve any purchase or possession of prohibited drugs.

#### 2009/074

During the course of this operation a registered source carried out activities outside the boundaries of the controlled operation in that the source self administered a prohibited drug. The PLEO for the operation did not inform the authorising officer in a timely manner, as is required by the Code of Conduct. The PLEO advised the undercover branch of the situation approximately one week later and asked for an assessment to be made of the continuing suitability of using the source in the operation. The undercover supervisor contacted the Special Applications Section to inform them of this situation as soon as he became aware and a report was provided to the authorising officer. As a result the authorising officer agreed that the operation could continue following the source assessment and agreed with the suggestion that strategies be put in place to prevent a recurrence of such a situation.

#### 2008/368

The civilian undertaking was signed on 08/04/2009, when the operation was completed on 24/03/2009.

#### 2009/135

Part 6(c) of the authority was incorrectly crossed out indicating that no civilian participants were authorised but the controlled activities of the civilian were listed.

In the following applications one or more mandatory considerations that are catered for in the application template used by NSW Police Force were not completed:

2009/073 2009/075 2009/086 2009/104 2009/169 2009/177 2008/237

In addition some notifications contained errors which were addressed by amended notifications.

#### **Additional inspections**

The records inspected at the Oxley Local Area Command related to controlled operations 2008/052, 2008/118 and 2008/135. In all of these operations the controlled activities were accounted for in sufficient detail to allow the reporting requirements of the *Law Enforcement (Controlled Operations) Act 1997* to be complied with.

The records inspected at Mid North Coast Local Area Command involved a random selection of records from some of the following controlled operations 2007/049, 2007/157, 2007/183, 2007/200, 207/244, 2008/010, 2008/069, and urgent operations 2008/117 and 2008/136. In all of these operations the controlled activities were accounted for in sufficient detail to allow the reporting requirements of the *Law Enforcement (Controlled Operations) Act 1997* to be complied with.

The records inspected at the Lachlan Local Area Command related to controlled operation 2009/032. In this operation the controlled activities were accounted for in sufficient detail to allow the reporting requirements of the *Law Enforcement (Controlled Operations) Act 1997* to be complied with.

The records inspected at the Chifley Local Area Command related to controlled operations 2008/066 and 2008/203. In each of these operations the controlled activities were accounted for in sufficient detail to allow the reporting requirements of the *Law Enforcement (Controlled Operations) Act 1997* to be complied with.

## **NSW Police Force Service Professional Standards Command**

The records maintained by the NSW Police Force and reported on above, for security reasons, do not include those operations carried out by the NSW Police Force Professional Standards Command (PSC). The PSC maintains its own records which are subject to separate inspections by us. Specific data relating to the operations conducted by PSC is included in the tables annexed to this report.

- There were two authorities granted by the chief executive officer's delegate during the 2008–2009 reporting period. No applications for authorities were refused during the relevant period. There was one variation granted and no urgent applications applied for.
- Both operations involved the supply and possession of prohibited drugs.
- There were 48 law enforcement participants and no civilians authorised to participate in the controlled operations conducted under the authorities. The number of law enforcement participants authorised to be involved in each of the operations was 45 and three. The controlled activities authorised for these operations involved conversations and negotiations concerning the supply of prohibited drugs.
- In relation to the five operations which were completed by the PSC by 30 June 2009 and reported to the chief executive officer one involved conversations and negotiations concerning prohibited drugs, one involved an attempt to purchase prohibited drugs, two related to entering property and the use of electricity and one operation did not involve any controlled activities. There were six law enforcement participants who conducted controlled activities in the course of these controlled operations.

There were no delays in the notifications of these operations and all the applications and authorities of PSC controlled operations were generally in order and in compliance with the requirements of the Act.

# **NSW Crime Commission**

The records maintained by the NSW Crime Commission and inspected by us disclose the following information which is reported pursuant to s.23(2) of the Act. Specific data relating to the operations conducted by the NSW Crime Commission is included in the tables annexed to this report.

- There were eight authorities granted during the 2008–2009 reporting period and no applications refused. None were urgent applications. There were no variations granted in relation to these operations.
- Six operations targeted prohibited drugs offences, one of these also involved money laundering offences. One involved dealing with the proceeds of crime, and one involved firearm offences.
- There were 35 law enforcement participants and three civilian participants authorised to participate in the controlled activities conducted under those operations.
- There were nine law enforcement participants and two civilian participants who actually engaged in controlled activities for the purpose of the nine operations completed by 30 June 2008.
- The controlled activities carried out during these operations included, access restricted data and conduct electronic scans, enter enclosed lands, receive money suspected of being the proceeds of crime, and conversations and negotiations concerning the supply of prohibited drugs.

#### **Outcome of inspections**

During the inspections of the records of the Crime Commission, the following minor issue was noted:

The application for controlled operation 08/08024 indicated that a previous authority had been authorised. However, the details of the previous authority were not included.

In all other instances the records required to be kept by the NSW Crime Commission were kept in accordance with the *Law Enforcement (Controlled Operations) Act* 1997.

## **Independent Commission Against Corruption**

The records maintained by the ICAC and inspected by us, disclose the following information which is reported pursuant to s.23(2) of the Act. Specific data relating to the ICAC operations is included in tables annexed to this report.

- There were six authorities granted during the period to which this report relates. None were urgent applications. No applications for granting of authorities were refused. Two variations were granted.
- Four of the operations which were conducted were in respect to soliciting or receiving a corrupt benefit or reward. The other two operations involved using false or misleading documents with intent to defraud.
- There were five law enforcement participants and three civilian participants authorised to participate in the controlled operations conducted under the authorities.
- In relation to the eight operations completed by 30 June 2009, two involved conversations and/or activities
  associated with soliciting and/or receiving a corrupt benefit. Two operations involved giving or offering to give
  a benefit, obtaining or attempting to obtain a false or misleading document and aiding and abetting these
  offences. One involved agreeing to provide a corrupt reward, and one involved accepting a corrupt reward.
  Four civilians and two law enforcement participants engaged in controlled activities in the course of those six
  operations. Two operations did not involve any controlled activities.

All applications, authorities, variations and reports were in order, and in compliance with the requirements of the Act.

## **Police Integrity Commission**

The records maintained by the PIC and inspected by us, disclose the following information which is reported pursuant to s.23(2) of the Act. Specific data relating to the PIC operations is included in tables annexed to this report.

- There was one authority granted during the period to which this report relates. This was not an urgent application. There was no variation to this authority.
- The authority was conducted in respect to making a collusive agreement with a member of the NSW Police Force for the purpose of inducing the member to neglect their duty.
- There were two law enforcement participants authorised to participate in the controlled operations conducted under the authorities.
- The operation was completed by 30 June 2009, and no controlled activities occurred.

The records kept by the Police Integrity Commission complied with the requirements of the Act.

## **Australian Crime Commission**

The records maintained by the ACC and inspected by us, disclose the following information which is reported pursuant to s.23(2) of the Act. Specific data relating to the ACC operations is included in tables annexed to this report.

- There were nine authorities granted during the 2008–2009 reporting period and no applications refused. No urgent applications were made. No variations were granted.
- Eight operations targeted conspiracy to supply prohibited drugs and one involved make and use false instruments.
- There were nine persons authorised to participate in the controlled operations conducted and in each case that person was a civilian.
- Seven operations were completed during the reporting period, and the controlled activities engaged in while conducting these operations were conversations and negotiations concerning the supply of prohibited drugs. Seven civilians engaged in controlled activities in the course of those operations.

The records associated with the authorities were in order, and in compliance with the requirements of the Act.

## **Australian Federal Police**

During the reporting period the AFP did not conduct any controlled operations under this Act.

## **Australian Customs Service**

During the reporting period the ACS did not conduct any controlled operations under this Act.

# 6. Notifications

Section 21 of the *Law Enforcement (Controlled Operations) Act 1997* requires that the Ombudsman be notified in writing when an authority or any variation to an authority is granted and when the chief executive officer of the agency receives a report on the conduct of an authorised operation.

All agencies that conducted operations during the reporting period complied with the notification requirements set out in s.21 of the Act and clause 9, 10, 11 and 12 of the Regulation with the following exceptions<sup>7</sup>.

## **New South Wales Police Force**

Seven notifications of the granting of an authority were not received within the statutory time period of 21 days.
